Deadlines cargo arrival


All shipment should arrive before the following deadlines

Roadfreight	LTL	At least 2 days prior to delivery on stand
Seafreight	LCL	At least 10 days prior to delivery on stand
	FCL	At least 4 days prior to delivery on stand
Airfreight		At least 3 days prior to delivery on stand



General remarks

All solid wooden packing materials must meet the ISPM15 regulations and must be marked with the ISPM15 stamp as per below



Customs related matters

For shipments with origin outside the EU, we need the following documents for the customs clearance:

- proforma invoice / packing list in English, showing weights / dimensions and values / commodity description
- separate invoices for temporary importation and permanent importation
- if necessary: special certificates (health / veterinary)

All shipments entered under temporary importation may be subject to control and examination by EU customs for inward and outward movements.

Any exhibits remaining in The Netherlands or another country within the EU after closure of the exhibition are subject to duties and / or taxes. Payments must be guaranteed prior to removal of goods from the exhibition venue.

Any shipments arriving after our deadlines that require customs clearance will be subject to a rush procedure with no guarantee on timely delivery. However we will always do our utmost to get it done.
