1. Consignment guidelines and deadlines

1.1 Groupage and courier shipments

We strongly recommend to send your groupage or courier shipments to our warehouse in The Netherlands. We cannot guarantee an on-time delivery to the exhibition booth in case your shipment arrives later than 4Th November 2021.

2. Shipments from outside the EU

2.4 Documentation

For shipments with origin outside the EU, we need the following documents for the customs clearance:

All shipments entered under temporary importation are subject to control and examination by EU customs for inward and outward movements.

Any exhibits remaining in France or the EU after closure of the exhibition are subject to duties and / or taxes. Payments must be guaranteed prior to removal of goods from the exhibition venue.

Any shipments arriving after our deadlines that require customs clearance will be subject to a late arrival surcharge of 50% on our customs handling tariffs.

3. Marking of packages

Please number every package consecutively and make sure that the following information is indicated on every package:

We kindly ask you to use safe and strong packing material which is strong enough to be re-used after the show.

4. Insurance

6. Basic Conditions of Contract

All work undertaken is subject to the Dutch Forwarders terms and conditions Fenex, latest version, in conjunction with the conditions and rates for trade fair transportation. A copy will be sent on request.

The responsibility and liability of FAIREXX Logistics for Exhibitions BV as Fairs & Exhibitions forwarder, ends once the goods have been delivered to the stand, irrespective of exhibitor's or his representative's presence on the stand When written instructions fail, goods may be delivered to the stand commencing on the first day of the official build up period.

The responsibility and liability for return freight at the close of the exhibition starts only with the collection from the stand during the official dismantling period. The surrendering of documents by the exhibitor at the Forwarders office and the acceptance of same does not constitute any admission of responsibility or liability for freight which has not yet been collected from the stand. If the exhibition booth has been left, without the shipment being collected, shipment remains on the booth at exhibitors risk.

Externally recognisable damages must be stated on the work order / delivery order on delivery of the goods. Any claim can only be treated when made in writing and presented at our on-site office. Verbal claims only will not be accepted.

Our invoices will be due immediately after issuance without any further notice. Customers not known to us or with whom we have not agreed any terms of payment, will be asked to pay our invoice(s) before the event starts or on-site during the event or before return shipping of their exhibits.

Shipments arriving after the deadlines for cargo arrival a surcharge will be applied of 25%


For work to be effected before or after the regular workhours a surcharge will be applied at 50%
